At this point, we would like to remind that as Emaar, we may withdraw from using these cookies that we normally use on our Web Site, change their types and functions or add on new cookies to the Web Site. #### What are Cookies and How Emaar AVM's Web Site Uses them

Cookies are small text files sent to your device when you visit a web site. Later these cookies are sent back to the original web site at each future visit or on another web site recognizing this specific cookie. However, cookies are definitely not viruses. Rather than that, the cookies function as a memory for a web site and when you revisit that web site, it enables the site to recognize your device. The cookies may also remember your preferences (for example, they can develop the user experience depending on the number of visitors visiting that site and organize the advertisements based on the ones that are most suitable for you. Although cookies generally do not contain any personal data, they may be correlated to personal data if you disclose them.

# Cookies used in our Web Site and Purposes of Use

We are using both session cookies (existing only until you shut down your device) and permanent cookies (existing for longer periods of time defined before). Types of cookies we are using our Web Site can be generally divide into three categories: Absolutely Necessary, Performance and Functionality.

# **Absolutely Necessary**

Certain cookies on our Web Site are necessary for you to surf in and use the functions of our Web Site. These cookies do not collect any information about you for marketing purposes or in order to remember where you surfed on the Internet.

## **Performance/Analysis Cookies**

Some of the cookies on our Web Site collect information about how Web Site is used by the visitors; such information includes information on most visited pages or any receipt of error messages from the web pages. These cookies do not collect any identification information. All information collected by these cookies are unified and for that reason, they are anonymous. They are only used to improve the operational basis of our Web Site.

Our Web Site uses Google Analytics cookies. Information collected by these cookies will be transferred to and stored in the servers in USA by Google in line with confidentiality principles. ## **Functionality**

These cookies enable our Web site to remember your preferences and offer you developed and customized characteristics.

### **Third Party Cookies**

Our Web Site also allows third parties to download cookies into your device. For example, we post photo and video contents from the web sites such as YouTube and Flickr. When you visit a page containing that content, you may see the cookies coming from these web sites. Besides that, you will see the embedded 'share' buttons on some of our web pages. These buttons will help you to easily share contents on many popular social networks. When you click on these buttons, a cookie may be uploaded by the service whose content you decided to share. These third party cookies are not under our control. For more information about their use, please visit the relevant third party web site.

For the purposes defined in this Cookies Policy, your personal data may be processed without your consent if at least one of the data processing conditions required by law is relevant as described in the second paragraph of article 5 of the Law on Protection of Personal Data. Otherwise, your personal data may be processed only with your prior consent if one the data processing conditions required by law is not relevant. In any case, we may share your personal data as set out in this Cookies Policy with our business partners and suppliers from which we obtain services in the country and which are subject to confidentiality restrictions provided that you had granted your explicit consent as per article 8/1 of KVKK and with foreign our business partners under a contract provided that you had granted your explicit consent as per article 9/1 of KVKK.

Besides that, in order to achieve above-mentioned purposes and execute the business operations needed to carry out the activities of the group companies and in connection with the organizational changes occurring in the structure of the company such as division, merger, and acquisition, your personal data may be shared with the group companies of Emaar operating within the country (including specifically İstanbul Seyir Terası Otelcilik ve Turizm Yatırımları Ticaret A.Ş.) provided that you had granted your explicit consent as per article 8/1 of KVKK and with the group companies of Emaar operating at abroad including specifically Emaar Hospitality Group LLC and Emaar Properties PJSC provided that you had granted your explicit consent as per article 9/1 of KVKK.

Apart from the above, our company may be restructured while it changes and grows and may acquire new companies, our Companies may be transferred or all or substantial part of its assets may be transferred in part or in whole including net assets, it may merge with new companies or divisions may occur inside our Company. As a result of these structural changes, assets of our Company including personal data together with the personal data of our customers may be transferred. In case of such changes, you will be informed via e-mail, mail or public announcements about controlling your own personal data as per article 10 of KVKK and your explicit consent will be obtained when it is necessary.

## How to Control and Delete the Cookies?

Most of the web browsers accept cookies but you may change the settings of your web browser to refuse new cookies, to deactivate existing cookies or to notify you once new cookies are sent to your device. In order to do that, please follow the instructions provided by your device (usually available at the "Help", "Tools" or "Edit" toolbars. However, please do remember that you may lose some functions of the web site if you refuse or deactivate the cookies. Besides that, deactivating a cookie or cookie category will not delete that cookie from your device and you should do it by yourself.

Depending on the nature of your request, your request will be finalized on free of charge basis as soon as possible or at latest within 30 (thirty) days. However, if the procedure to be completed according to your requests requires extra costs, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
